All Fringe Benefits shall be paid on an HOURS WORKED basis.

- A. Classification differentials shall not apply to Apprentices.
- B. At no time shall the Apprentice rate exceed the Journeypersons rate on any project.
- C. Overtime and Shift Differentials for Apprentices shall be paid in accordance with the agreement under which Apprentice is working.
- D. Apprentices are not permitted to work outside of the jurisdiction of the 33 counties of Western Pennsylvania
- E. Journey Worker to Apprentice ratio is 4:1 on prevailing wage rate work.
