OVERTIME:

- a.) Overtime rates (time and one-half) to be paid on all hours after the 10th hour on any day except Sunday and Holidays, which are double time.
- b.) Overtime rates (time and one-half) to be paid on all hours in excess of 40 hours in any week except for Sunday and Holidays which are double time.
- c.) On the Saturday before the following two (2) holidays, Memorial Day and Labor Day, any work done on that Saturday shall be paid at time & one half.

FOREMAN:

The Foreman's rate is \$2.00/hr above the Journeyman's rate. There shall be a local foreman on all jobs. There shall be two (2) Journeyman employed by each contractor.

A copy of the report form must be made and sent together with a check to cover the International Pension and Research & Development Fund payments at \$2.44 per hour to the **National Roofing Industry Pension Plan, 3001 Metro Dr., Suite 500, Bloomington, MN 55425**. Make the check payable to the National Roofing Industry Pension Plan.

A copy of the report form must be made and sent together with a check to cover the Health and Welfare payments at \$8.29 per hour to the **Indiana State Council of Roofers Health and Welfare Fund, P.O. Box 5769, Lafayette, IN 47903**. Make the check payable to the Indiana Council of Roofers Health and Welfare Fund.

It is important that the forms show the contractor's name, the employees name and social security number and the total hours worked by each employee. The above procedure should be followed for every month of the year except for the November report (October hours worked) which must be received by the fifteenth (15th) of Nov.
