The following rates apply to *Heavy Highway & Building Construction Hazardous Waste Projects* in Mahoning, Trumbull and Columbiana Counties in Ohio.

Wages for employees working in direct contact with a hazardous/toxic material which is classified Level A or Level B by the United States Environmental Protection Agency and who are required to wear personal protective equipment for respiratory, skin or eye protection for that level of work shall be paid an additional 20%

Wages for employees working in direct contact with asbestos material and who are required to wear personal protective equipment for respiratory, skin or eye protection for that level of work shall be paid an additional

Those rates are as follows for Levels A & B and asbestos:
