SUBJECT: **NEW WAGE - FRINGE SCHEDULE**

Wage Rates Effective June 1, 2025 - May 31, 2026

Group #1: \$32.39 Building and Construction Laborer; Asbestos Removal; Asphalt Paving; Railroad Labor Construction; Carpenter Tenders; Minimum Wage for skilled and common laborer unlisted.

Mortar Mixer (hand or machine); Mason Tender; Flexicore; Jack Hammer Operator; all machine driven tools (electric, gas or air) and operation of all pumps under 4"; Spikers; all men working in concrete such as pouring; puddling; raking and conveying; all scaffold help; scrap iron burning

Hod Carrier; all work done by Laborers 7 ft. or more in depth; rough terrain fork lift driver when tending masons.

Laborers (except jack hammer) working on repair of blast furnace or coke plant and auxiliary facilities; Jack Hammer Operation in trench or shaft 7 ft. or more in depth; Concrete Buster; pipe layers; powder and dynamite; muckers, tunnel and caisson; Laser Beam Operator, Jack Hammer on blast furnace or coke plant and auxiliary facilities.

Wrench Laborer; miner-air tool; guniting and sandblasting, pump-crete operations; Build-up rates - Blast Furnace; Ram Tight; Bellman and Hook-Up Man; Lancing Blast Furnace

Group #2: \$32.75 Hazardous Waste Rate Level A
Hazardous Waste Rate Level B
Hazardous Waste Rate Level C
Hazardous Waste Rate Level D

Group #3: \$23.59 Laborers performing residential building construction on four stories or less.

Foreman will receive \$1.00 per hour above the rate he is supervising.
